Knox County Junior Fair Board Bylaws

Article I: NAME

SECTION I: The official name of the organization shall be the Knox County Junior Fair Board.

ARTICLE II: PURPOSE

SECTION I: The main purpose of this board is the training and development of young people in the areas of leadership, community organization and county fair operation; to develop an association of youth from the general community that are helping to augment Fair awareness throughout the County

ARTICLE III: MEMBERSHIP

SECTION I: Open to all youth 14 – 19 years of age (and in high school), as of January 1 of the year of application. Each member will serve for a one-year term.

SECTION II: The membership of the committee shall include youth that are eligible to participate in the Knox County Junior Fair:

- a) 4-H Club
- b) FFA Chapter Members
- c) FCCLA Chapter Members
- d) Girl Scouts
- e) Boy Scouts
- f) Junior Grange Members

SECTION III: The term of membership on the Junior Fair Board shall begin January 1 and end on August 31 of each calendar year.

SECTION IV: A member of the Junior Fair Board may serve more than one year by reapplying for an additional year of membership if he/she is accepted by the Membership Selection Committee and if he/she has met the prior year Junior Fair Board obligations in a satisfactory manner.

- a) Each Junior Fair Board Member must meet the following requirements in order to return to the board:
- 1) Each member is required to acquire sixty-five working hours prior to the Knox County Fair.
- 2) Knox County Junior Fair Board's Officers are individually required to acquire seventy-five working hours prior to the Knox County Fair.
- 3) Each member is required to acquire at least forty approved working hours during the Knox County Fair.
- 4) Each member is required to work at least one livestock show during the Knox County Fair.
- 5) Each member is required to work at least two office shifts during the Knox County Fair.
- 6) Each member is required to participate in the Knox County Junior Fair Livestock Sale.

SECTION V: If a Junior Fair Board member wishes to serve an additional term, he/she must submit a request by August 31 to the Knox County Junior Fair Coordinator wishing to be in consideration for the following year.

SECTION VI: Attendance at all Junior Fair Board meetings is mandatory. Membership on the Junior Fair Board shall be terminated immediately following the third missed event or meeting without a valid excuse and/or phone call to the fair office. The Junior Fair Coordinator will send a letter to the terminated Junior Board member in a timely manner and will have the letter co-signed by an advisor.

SECTION VII: New members will be notified by mail by January 5, by the Junior Fair Coordinator after they have been confirmed a position on the Junior Fair Board.

SECTION IX: Code of Conduct

- 1) No members of the Junior Fair Board shall associate with drugs, alcohol or tobacco of any form while working on Junior Fair Board activities.
- 2) Members should conduct themselves with high standards of leadership and responsibility at all times.
- 3) Members of the Junior Fair Board shall not use any obscene language while working at any Junior Fair Board activity.
- 4) Each member of the Junior Fair Board should conduct him/herself in an appropriate manner in order to set a good example for others.

ARTICLE IV: APPLICATIONS

SECTION I: Applications for Junior Fair Board membership will be accepted on the dates as posted. Interviews will be held in December as determined by the Membership Selection Committee.

SECTION II: The Membership Selection Committee shall be composed of the Junior Fair Coordinator and the Junior Fair Board advisors. The Fair Board of Directors shall be invited to participate as well.

ARTICLE V: VOTING PROCEDURE:

SECTION I: Voting will follow Robert's Rules of Order. If there is a dispute over the decision of the chairperson, the matter(s) will be taken to the Junior Fair Board Junior Fair Coordinator.

ARTICLE VI: OFFICERS

SECTION I: President

- 1) Presides over all meetings of the Junior Fair Board and develops agenda with appropriate consultation with the Junior Fair Coordinator.
- 2) Represents the Knox County Junior Fair Board in their best ability at ALL times.
- 3) This person is the first point of contact between the Junior Fair Coordinator/Senior Advisors and the Junior Fair Board.
- 4) This person will serve as the Knox County Junior Fair Board liaison to the Knox County Senior Fair Board.

SECTION II: Vice President

- 1) This person presides over meetings in the absence of the President.
- 2) Assists the president in maintaining order.

SECTION III: Secretary/Treasurer

- 1) Keeps minutes and maintains an accurate record of all meetings.
- 2) Records and distributes all minutes and agendas and keeps a copy of each for the Junior Fair Board's and Fair Board's permanent files.
- 3) Monitors and reports on the Junior Fair Board general account balance at each meeting.

SECTION IV: Historian

- 1) Maintains archives of current and past events. Responsible for clipping all newspaper articles and associated materials printed about the fair.
- 2) Takes pictures and maintains a scrapbook of all Junior Fair Board activities.
- 3) Works with the Reporter to design and construct the Junior Fair Board window during the annual fair.

SECTION V: Reporter

- 1) Serves as the Junior Fair Board publicity coordinator.
- 2) Handles all press releases regarding Junior Fair Board activities and meetings.
- 3) Creates and submits social media posts to Junior Fair Coordinator.

ARTICLE VII: ELECTIONS

SECTION I: Elections

- 1) To be held during the April board meeting.
- 2) All members may run for any office except President or Vice President, which require one year of prior Junior Fair Board officer experience.
- 3) Officer applications are due April 28th.
- 4) All voting for office will be by closed ballot.
- 5) Junior Fair Coordinator and senior advisors will count the ballots and advise the Junior Fair Board of election results.

ARTICLE VIII: STANDING COMMITTEES

See 2019 Junior Fair Board Committee List

SECTION IV: There shall be other committees as deemed necessary.

ARTICLE IX: AMENDMENTS

SECTION I: Amendments will be made by majority vote of the Junior Fair Board.

ARTICLE X: ADVISORS

SECTION I: Criteria

- 1) There will be a minimum of two senior advisors, at least one of who will be a representative of the Knox County Fair Board of Directors.
- 2) College students may opt to serve as Junior Advisors to the Junior Fair Board. The number of Junior Advisors will not exceed five. Junior Advisors will be selected by the Junior Fair Board Coordinator and will assist the junior fair coordinator and the senior advisors. Junior advisors are not voting members of the Junior Fair Board.
- 3) Any advisor may be removed at the discretion of the junior fair coordinator and his/her fellow advisors if their conduct is deemed inappropriate.

ARTICLE XI: MEETINGS

SECTION I: The Junior Fair Board will meet monthly. (See calendar for specific dates and times)

GENERAL JUNIOR FAIR INFORMATION

EXHIBITION RULES

- The Knox County Junior Fair shall include the following youth organizations: 4-H, FFA, Girl Scouts, Boy Scouts, FCCLA, and Junior Grange. The completion of member evaluation/project judging is required before a Junior Fair exhibitor can participate in any Junior Fair competition at the fair or receive premiums for exhibiting individual project work.
- No youth 19 years of age, as of January 1st, of the current year may exhibit in the Junior Fair. This applies to all youth organizations represented in the Junior Fair.

- Exhibitors living inside the Knox County boundaries but belonging to a non-4-H organization outside the county boundaries are still eligible to exhibit at the Knox County Junior Fair. However, they must follow all rules and deadlines as stated. All Junior Fair enrollment (including 4-H/FFA/Scouts) for fair participation is due in the Ohio State University Extension Office by deadline of March 15 (unless March 15 falls on Saturday or Sunday then the deadline shall be the following Monday) annually.
- Exhibitors must be enrolled in the project area(s) by this time or will be considered ineligible for fair participation (no exceptions). Boys and girls affiliated with those organizations in Knox County are eligible to exhibit subject to the rules of their respective organizations. Junior Fair exhibitors shall not exhibit any project work or supervised agricultural experience work for one Junior Fair organization that was completed for credit and /or exhibit for any other Junior Fair organization or school assignment. Duplicate projects cannot be taken in two or more Junior Fair organizations during the same project /school year, including 4-H and FFA membership in multiple counties.
- All exhibitors must show and their own project to receive ABC grade and premium with two exceptions: a. Medical reason approved by the Junior Fair Coordinator. b. Showing in another Knox County Junior Fair Show. If a replacement is necessary, a current Knox County Junior Fair Exhibitor may show the animal, if approved by the start of the show.
- All exhibitors must sell their own market project with three exceptions:
 - o Medical reason approved by the Junior Fair Coordinator.
 - Showing in another Knox County Junior Fair Show.
 - o Exhibiting an Ohio State Junior Fair Project approved by Junior Fair Coordinator prior to the sale. If a replacement is necessary, a current Knox County Junior Fair Exhibitor may sell the animal, if approved by the start of the sale.
- Parents and advisors are not permitted in the Show Ring during the show, unless in case of emergency.
- Tampering or altering an official Junior Fair document will result in IMMEDIATE loss of all Junior Fair exhibition, showing, sale and participation in extracurricular activities and Junior Fair privileges. Participation in Junior Fair Shows and activities are reserved for Junior Fair exhibitors who are enrolled with the Junior Fair program by March 15th of the current year. Only officially enrolled exhibitors may participate and compete for awards and recognition in official, competitive Junior Fair shows and or activities.

PROJECT REQUIREMENTS

Possession Information

- Products exhibited must be from projects carried in a Junior Fair organization and must be the property of
 the exhibitor. All exhibits must be current year products. The same product cannot be exhibited more than
 one year, except for equine, livestock breeding projects, dairy market feeders and beef feeders.
- All animals must be in the care of and fed by the exhibitor from their specific possession date until release time, unless otherwise stated in the individual specie sections.
- Horses and Llamas/Alpacas are the only animals that may be leased. Horse lease guidelines are available
 from the OSU Extension office and must be turned in by May 1st. Llama/Alpaca lease guidelines are due
 at entries in June.

Quality Assurance

- Quality Assurance is a mandatory educational process for all livestock exhibitors to exhibit at the fair. See Livestock Requirement Summary for dates and times.
- These rules are a supplement to rules already stated in other sections of the fair book.
- All animal exhibitors (except dog and llama exhibitors) must complete the annual Quality Assurance Program to exhibit.
- See Ohio's Livestock Tampering Exhibiting Rules Quality Assurance 901-19-07.

Entries

- Entries are a mandatory process for all livestock exhibitors to exhibit at the fair. See Livestock Requirement Summary for dates and times
- The Online Entry Portal will be accepting entries from June 1st until June 20th at midnight.
- 4-H and FFA members have the option to go to Ramser 4-H Center on one of the following dates to fill out fair entries:
 - June 2 or June 3, 2021 1:00 to 6:00 p.m.

Junior Exhibitors May Show in the Senior Fair By:

- Purchasing an exhibitor's ticket and paying the entry fee if showing under their parent's, family or farm name.
- Paying the entry fee only if showing one or two entries.
- Purchasing an exhibitor's ticket and paying the entry fee if three or more animals are entered.
- See the Knox County Senior Fair Board section of this book for entry dates and forms.

Livestock Interview Judging

- All members exhibiting their livestock at the 2021 Knox County Junior Fair will need to attend one of the
 two Livestock interview Judging events listed below. If any exhibitor does <u>not attend</u> one of the Livestock
 Interview Judging Dates, they <u>will not</u> be eligible to show livestock at the 2021 Knox County Junior Fair.
 - o July 5, 2021 at 1:00 to 6:00 p.m.
 - o July 12, 2021 at 1:00 to 6:00 p.m.
- Livestock Interview Judging is a mandatory interview process for all livestock exhibitors to exhibit at the
 fair. Exhibitors must bring the following items to judging completed project book for each specie they are
 showing during the 2021 Knox County Junior Fair, a feed tag or ration list from their feed with each
 project book.

Admission Passes/Wristbands

Will be distributed to:

- Eligible Junior Fair Exhibitors
- Adult Volunteers

Cloverbud Aged Members and younger will be admitted free.

Wristbands will be distributed at Miscellaneous/Food & Nutrition/Clothing/Rocket Judging (for non-livestock participants and adult volunteers only) on:

• June 30, 2021 at 1:00 to 6:00 p.m.

Wristbands will be distributed at Livestock Interview Judging on:

- July 5, 2021 at 1:00 to 6:00 p.m.
- July 12, 2021 at 1:00 to 6:00 p.m.

If a wristband is lost and you would like to replace it, you will need to go to the Senior Fair Board Office and purchase a youth fair pass (\$25.00).

Back Numbers

Back Numbers will be distributed at Livestock Interview Judging on:

- July 5, 2021 at 1:00 to 6:00 p.m.
- July 12, 2021 at 1:00 to 6:00 p.m.

If a back number is lost and you need to replace it, you will need to go to the Junior Fair Board Office and purchase a new one (\$5.00).

Drug Use Notification

- See Ohio's Livestock Tampering Exhibiting Rules Prohibited practices 901-19-04 and 901-19-06.
- These rules are a supplement to rules already stated in other sections of the fair book.
- All exhibitors of swine, market lambs, beef feeders, market beef, market dairy steers, dairy market feeders, market goats, lactating dairy goats, lactating dairy cows, tom turkeys and chicken broilers must submit a completed Drug Use Notification form for each animal by Thursday, July 22, 2021.

Other Junior Fair Requirements

- United Producer's Livestock requires all exhibitors of ruminant animals (market beef, market dairy steers, dairy market feeders, market goats and market lambs) must submit a feed additive statement to be turned in by Thursday, July 22, 2021.
- Ractopamine Affidavit for swine projects must be submitted Thursday, July 22, 2021.

ON THE FAIRGROUNDS DURING FAIR WEEK

- All precautions shall be taken to prevent injury or theft of exhibits. However, neither the Senior Fair Board nor Junior Fair Board will be responsible in either case.
- All animals must enter from McKenzie Road through the back gate and be inspected on the truck by the Knox County Fair Veterinarian. Animals will not be allowed to be penned without being checked. Exhibitor is responsible for seeing that the veterinarian has checked all animals. This will be enforced. Animals may not enter the fairgrounds except at designated hours.
- Any animal brought to the fair that does not match the entry and registration material filed will be disqualified and asked to be removed from the fairgrounds.
- For breeding animals, registration papers must be furnished on request for all registered animals.
 - o Exhibitors may show an animal registered under a brother/sister name.
 - o No animal, shown as a non-market project, shall be advertised or sold prior to the completion of the project or before the end of the fair.
- For market animals and equine, exhibitors may show an animal entered under a sibling's name.

Move-In

- Equipment move-in will be held Thursday, July 22nd, from 6:00 8:00 p.m. for all livestock species.
- Junior Fair Board Members will have *priority* move-in and placement of their equipment. Please respect their equipment placement when moving your equipment into the fair.

Housing

- All Junior Fair livestock must be housed in Junior Fair Buildings in the pre-assigned stalls or pens.
- Housing assignments are only to be changed at the discretion of the Junior Fair Coordinator.
- All animals not entered in the Junior Fair area must be housed in the open class area.
- No animal entries over and above the number permitted to show will be weighed or housed on the fair grounds.
- Exhibitors must clean out their pens or stalls completely and receive approval before leaving.
- Sawdust, wood shavings, mulch, ground corncob and straw will be permitted for livestock bedding.

Feeding, Watering and General Animal Care

- Each exhibitor is responsible for the care and feeding of his/her animals at all times.
- Each exhibitor must furnish all the feed and feeding/watering equipment for his/her animals.
- Each exhibitor is responsible for providing plenty of clean, fresh water for his/her animal(s) daily.
- Any animal not properly cared for as determined by the Senior Fair Board, Junior Fair Coordinator and/or fair veterinarian, shall be immediately removed from the fairgrounds, with all premiums forfeited and animal excluded from the auction. The exhibitor will not be permitted to exhibit animal project in the Knox County Junior Fair the following year.
- No outside scales will be permitted on the fairgrounds during the week of the fair.
- Release times of exhibits are to be followed (refer to *Release Times* listed in each specie section). If an exhibitor does not follow these guidelines, they will not be permitted to show any exhibit the following year at the Knox County Junior Fair.

Show Classes

- Exhibitors with more than one animal/specie must declare at the weigh-in of the last animal which animal will sell.
- No breed show will be held in market classes.
- Over/underweight animals must show to receive premium but are ineligible to compete for champion or reserve champion and are ineligible for the sale.
- Unworthy entries may be disqualified for premiums by the judges or the Senior Fair Board.
- All dehorned and castrated (no viable testicular tissue) animals must be completely healed.

Judging

- Exhibits will be graded "A, B or C" and ribbons awarded on that basis. In livestock exhibits, the contribution of the showman is considered and included in the final grade.
- Premiums will be paid based upon the exhibits grade and the grade received from the livestock interview and/or book judging.

Premiums

- Premiums will be paid to Junior Fair exhibitors who have the required exhibit displayed, project registered with an active Junior Fair organization, the appropriate entry submitted by the deadline date, required interview judging completed and the project shown in the required class (all livestock).
- Exhibits shown under one class number will not receive a premium under any other class number in the Junior Fair.
- Exhibitors may receive premiums for a maximum of FOUR (4) large livestock (dairy, horses, beef, sheep, swine, llama and goat) classes in the Junior Fair. ANY number of miscellaneous entries can be made, providing they are a part of the exhibitor's project.
- Junior Fair members who do not show or display at the fair do not receive premiums or a fair pass.
- In 4-H, a premium will be paid for a "member evaluation" grade.
- Parents or advisors may pick up premiums.
- Premiums will be paid only at the fair during scheduled hours.
- Premiums for animal grades will be available 48 hours after the exhibitors' last show.
- Pre-Fair livestock interview judging will be conducted for all livestock projects and will affect premiums, as follows: An "A" Grade - No difference A "B" Grade - Lower premium \$.50 A "C" Grade - Lower premium \$1.00
- Premiums and awards may be withheld from those exhibitors who fail to follow junior fair rules and keep pens clean.
- All Junior Fair premiums will be paid out after the fair to the club advisors. A club advisor or designee can pick-up premiums for all of their club members on September 1 from 3-7 p.m. at the Ramser 4-H Center. Failure to pick-up will result in the premiums being forfeited.

Junior Fair Trophies

- Award needs and class make-up are determined by the entry forms filled out during the three posted entry days.
- Awards will be given to exhibits with an "A" grade only.
- Special awards may be given if approved by Junior Fair Coordinator.
- Breed classes with less than three entries at fair will be combined into the "other breed" class.
- Anyone interested in sponsoring a trophy should contact Yvonne Clutter at 740-427-3380.

Staying Overnight Note

Parents will be responsible for Junior Fair exhibitors staying overnight on the grounds.

Exhibitors may stay if all of the following conditions are met:

- Only exhibitors of livestock may stay overnight.
- There must be adult supervision in the barn.
- Exhibitors may stay only if their livestock is on the grounds.
- Exhibitors must stay in the same barn their animal is housed in only if there is adult supervision that is approved by Senior Fair Board.
- The exhibitor must display a qualifying Overnight Pass. Permission forms to receive the overnight pass must be turned in by July 22, to the Knox County OSU Extension office. For security reasons, no late permission forms will be accepted.

Showmanship Contest

- Age in these departments is the member's age as of January 1, of the current year.
- Showmanship classes will be determined by the number of entries; however, the following guidelines will apply:
 - First Year Showmanship Exhibitors 11 years old or younger and showing specie for the first time.
 - O Junior Showmanship Exhibitors 11 years old and younger but if no Intermediate Showmanship class is offered based on numbers this class will include youth through age 14
 - o Intermediate Showmanship Exhibitors 12 to 14 years old
 - o Senior Showmanship Exhibitors 15 years old and older
 - o Master Showmanship Overall winner of each species showmanship competition
- Showmanship entries must be made by June 20.
- An exhibitor may win showmanship in more than one specie a year.
- An exhibitor must show his/her own project.
- Show order will be posted prior to the show.
- Species not having a separate showmanship show will start with showmanship.

Showman of Showmen Competition

- Current winners of the Master Showmanship classes may participate in the Showman of Showmen contest.
- If a participant has won Master Showmanship in more than one species in the current year, he/she will choose which specie to represent in the contest.
- Each participant must show all species offered.
- Late arrivals will not participate.
- In the event a first-place master showman declines participation, the second-place master showman in that specie is eligible to participate in the competition.
- Copies of rules and regulations will be presented to each winner at each specie show when they receive their specie showmanship trophy.
- The winner must indicate on the official form if he/she is going to participate in the Showman of Showmen competition by 10:00 a.m. the following day. Forms are to be turned into the Junior Fair Coordinator.
- In event of unavailability of specie of animal, the Showman of Showmen Committee will, at their discretion, provide an alternative means of judging that specie or omit that species.
- Awards will be determined by the committee.

Grievances

- All complaints or grievances must be signed and presented to the Junior Fair Coordinator. Complaint
 forms can be obtained at the Junior Fair Board Office. Grievances must be accompanied by a \$100 nonrefundable fee.
- See Rule Violations section of the Knox County Fair Book.
- Damage to the fairgrounds property committed by a Junior Fair exhibitor my also result in premium removal and payment for damages. Serious violations may cause the exhibitor and/or the exhibitor's family to be barred from showing in future Knox County Fairs. Unless fraud and/or deceptions are involved, all championship placings will stand.
- Repeat violators will be barred from future Junior Fair participation.

Judging

- All Junior Fair Judges decisions are **final**.
- No one is to address or confront a Junior Fair Judge. All questions need to be directed through the Junior Fair Coordinator.

KNOX COUNTY LIVESTOCK FITTING AND GROOMING REGULATIONS:

- These rules are a supplement to rules already stated in other sections of the fair book.
- Washing is considered part of fitting and grooming.
- Exhibitors will be expected to fit and groom their own livestock for show while they are on the grounds.
- Pre-high school aged youth and high school aged youth exhibiting specie for the first time may have assistance with clipping. All exhibitors, regardless of age, may have assistance with tail, switch and mane preparation as well as the hoof, feet and nails.
- Persons that are permitted to assist exhibitors are as follows: Parents, grandparents, brothers, sisters, Current Knox County 4-H and FFA members, Knox County 4-H volunteers, and/or Vo-Ag instructors from the exhibitor's chapter.
- The word "assistance" implies that the exhibitor is receiving some help but is the primary person responsible for doing the work while learning the art of fitting and grooming.
- Adult participation in project work should be limited to guiding and teaching.
- In all cases, members hold primary responsibility for their own projects.
- Special requests may be made to the Senior Fair Board or Junior Fair Coordinator for special help if safety or other circumstances need to be considered.

OHIO'S LIVESTOCK HEALTH EXHIBITION RULES

901:1-18-01 Chapter's application.

- (A) Animals listed in this chapter when moved or imported into Ohio for exhibition purposes only shall comply with the requirements of this chapter and when in compliance with the provisions of this chapter shall, with the exception of rules governing movement and importation of quarantined animals, be exempt from any other rules governing movement within or importation into Ohio.
- (B) Animals moved within or imported into Ohio for any purpose in addition to exhibition shall meet all movement and import requirements of Chapter 901:1-17 of the Administrative Code.

901:1-18-02 Definitions.

As used in this chapter:

(A) "Exhibition" means any public show of animals which is sponsored by or under the control of an Ohio county or independent agricultural society organized under chapter 1711. of the revised code; or the Ohio state fair; or which is assembled for a period which exceeds thirty-six hours or contains animals of origins other than Ohio.

- (B) "Certificate of veterinary inspection" means a form from the state of origin which has been issued and completed by a licensed and accredited veterinarian attesting to the health status and identification of an animal listed thereon.
- (C) "Approved veterinarian" means any licensed and accredited veterinarian approved by the Ohio department of agriculture, or an employee of the Ohio department of agriculture or the United States department of agriculture, animal plant health inspection service, veterinary services.
- (D) "Licensed and accredited veterinarian" means a person who is licensed by the state of Ohio to practice veterinary medicine and who is certified by the United States department of agriculture, animal plant health inspection service, veterinary services, to be an accredited veterinarian.
- (E) "Residue" means any poisonous or deleterious pesticide governed by 40 C.F.R. 180, any poisonous or deleterious substance governed by 21 C.F.R. 109.6, or any other substance governed by 21 C.F.R. 556.
- (F) "Contagious or infectious disease" means any disease, including any foreign animal disease, or vector, capable of transmission by any means from a carrier animal to a human or to another animal and includes dangerously contagious or infectious diseases.
- (G) "Tuberculosis accredited free herd" is one that has passed at least two consecutive annual negative official tests for tuberculosis in accordance with the "Uniform Methods and Rules Bovine Tuberculosis Eradication" and has no other evidence of bovine tuberculosis.

901:1-18-03 Exhibitions: sanitation, inspection and records.

- (A) Each entity sponsoring an exhibition shall have in attendance an approved veterinarian for the duration of the exhibit.
- (B) Each entity sponsoring an exhibition shall:
 - (1) Immediately, prior to an exhibition and under the direction of the approved veterinarian, thoroughly clean and disinfect each building, pen, stall, ring or other enclosure in which animals are to be quartered for exhibition.
 - (2) Have the approved veterinarian:
 - (a) Examine the certificate of veterinary inspection when required for an animal brought to the exhibition.
 - (b) Inspect within a reasonable time of arrival each animal brought to the exhibit for symptoms of any infectious or contagious diseases.
 - (c) Daily inspect each animal present at the exhibition for symptoms of infectious or contagious disease.

- (3) Maintain a record for one year from the date of the exhibition of each animal present at the exhibit. The record shall contain the name and address of the owner of each animal and the species and breed of the animal.
- (4) May order the immediate removal of any animal which in the opinion of the approved veterinarian places other animals at unacceptable risk of disease.
- (C) An exemption from the requirements of paragraph (B)(1) of this rule may be requested from the department and will be granted when, in the judgment of the department, cleaning and disinfection will serve no purpose. By way of example only, cleaning and disinfection will generally serve no purpose in a newly constructed building that has never been occupied.

901:1-18-04 Exhibitors.

- (A) No person shall present for exhibition or exhibit an animal which he knows or has reason to suspect is affected with or has been exposed to a dangerously contagious or infectious disease or residue.
- (B) The owner or bailee of an animal with symptoms of an infectious or contagious disease shall, when directed by an exhibition official, the approved veterinarian, or an employee of the Ohio department of agriculture, immediately remove the animal from the exhibition premises.
- (C) Upon request, each person who presents for exhibition or exhibits an animal, shall make available any certificate of veterinary inspection, registration certificates, vaccination certificate, and other documents to exhibition officials, the approved veterinarian or an employee of the Ohio department of agriculture.
- (D) Each person who presents for exhibition or exhibits an animal for which a certificate of veterinary inspection is required by rules 901:1-18-01 to 901:1-18-11 of the Administrative Code shall forward a copy of the certificate of veterinary inspection to the Ohio department of agriculture's division of animal industry.

901:1-18-05 Poultry and fowl.

- (A) All turkeys, chickens and gamebirds moved within or imported into Ohio for exhibition must:
 - (1) Originate directly from a flock or hatchery which is a participant in the national poultry improvement plan for the eradication of disease and be accompanied by documentary evidence that they meet the requirements of this paragraph; or
 - Originate directly from a flock which has had a negative test for pullorum/fowl typhoid disease within twelve months preceding the opening date of exhibition and be accompanied by documentary evidence that they meet the requirement of this paragraph; or

- (3) Have had a negative test for pullorum/fowl typhoid disease, within ninety days, preceding the opening date of the exhibition and be accompanied by documentary evidence that they meet the requirement of this paragraph: or
- (4) Be tested for pullorum/fowl typhoid disease upon arrival at the exhibition by a tester approved by the Ohio department of agriculture and found negative.
- (B) The rapid whole blood test shall not be used to test turkeys for compliance with the requirements of paragraph (A)(2), (A)(3) and (A)(4) of this rule.
- (C) Waterfowl, doves and pigeons are exempt from this rule

901:1-18-06 Cattle.

- (A) Cattle moved within Ohio for exhibition:
 - (1) The animals presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
- (B) All cattle imported into Ohio for exhibition must:
 - (1) Be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition and be identified with official individual identification.
 - (2) Originate from a tuberculosis-accredited free herd, an accredited free state or zone, or a modified accredited advanced state or zone.
 - (3) If originate from a modified accredited state or zone must comply with Rule 901:1-17-03 of the Administrative Code.
 - (4) If originate from an accreditation preparatory or a non-accredited state or zone are prohibited from exhibition.
 - (5) If from a brucellosis class A state or area/zone must be negative to an official brucellosis test within thirty days of the opening date of the exhibition unless: they are under six months of age, steers, or official vaccinates under twenty months of age (dairy) or twenty-four months of age (beef); and
 - (6) If from a brucellosis class B or C state or area/zone must meet all requirements for preentry testing as specified in 9 C.F.R. 78.9 and obtain an Ohio permit prior to movement.
- (C) Cattle from a brucellosis certified free herd or class free state or area/zone are not required to be brucellosis tested.

901:1-18-07 Goats.

- (A) Goats moved within Ohio for exhibition:
 - (1) The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
 - (2) All sexually intact animals and any wether eighteen months of age and older must be identified with an official identification as defined in rule 901:1-13-04 of the Ohio Administrative Code.
- (B) Goats imported into Ohio for exhibition:
 - (1) Must be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition and be identified with official individual identification.
 - (2) The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease; and
 - (3) The owner and the veterinarian must attest to the following statement written on the certificate of veterinary inspection "the goats in this shipment are not known to be under any movement restrictions because of scrapie."
 - (4) Originate from a tuberculosis accredited free herd as defined in rule 901-18-02 (G) of the Administrative Code for bovine tuberculosis eradication; or
 - (5) Originate from a bovine accredited free state or zone, or a bovine modified accredited advanced state or zone; or
 - (6) Originate from a bovine modified accredited state or zone must comply with Rule 901:1-

17-06 of the Administrative Code.

(C) If originate from a bovine accreditation preparatory or a bovine non-accredited state or zone are prohibited from exhibition.

901:1-18-08 Horses, mules and ponies.

- (A) Horses, mules and ponies moved within Ohio for exhibition:
 - (1) If not under quarantine and if they are free of any signs of a contagious or infectious disease; and
 - (2) If the animal is twelve months of age or older, the exhibition manager may require that the animal has been tested and classed negative to an official test for equine infectious anemia within twelve months of the opening date of the exhibition.
- (B) Horses, mules and ponies imported into Ohio for exhibition:

- (1) Shall be accompanied by an official certificate of veterinary inspection issued within thirty days of the opening date of the exhibition: and
- (2) If the animal is twelve months of age or older, it shall be accompanied by evidence the animal was negative to an official test for equine infectious anemia within twelve months of the opening date of the exhibition; and
- (3) Upon request by an authorized representative of the Ohio department of agriculture, the person responsible for each animal must make available a chronological list of dates, places and events attended by this animal within thirty days prior to entry into Ohio.

901:1-18-09 Sheep.

- (A) Sheep moved within Ohio for exhibition:
 - (1) The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
 - (2) All sexually intact animals and any wether eighteen months of age and older must be identified with an official identification as defined in rule 901:1-13-04 of the Ohio Administrative Code.
- (B) Sheep imported into Ohio for exhibition:
 - (1) Must be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition and be identified with official individual identification: and
 - (2) The animal presented for exhibition must show no symptoms or evidence of an infectious or contagious disease; and
 - (3) The owner and the veterinarian must attest to the following statement written on the certificate of veterinary inspection "the sheep in this shipment are not known to be under any movement restrictions because of scrapie."

901:1-18-10 Swine.

- (A) Swine moved within Ohio for exhibition:
 - (1) The animals presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
 - (2) Will be exempt from the requirement of a certificate of veterinary inspection if they originate immediately and directly from a pseudorabies stage V area.
 - (3) Swine originating from a pseudorabies stage IV area shall:

- (a) Be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition: and
- (b) Originate from a pseudorabies qualified herd; or
- (c) Be negative to an official pseudorabies test within thirty days of the exhibition.
- (B) Swine imported into Ohio for exhibition:
 - (1) Must be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition: and
 - (a) Originate immediately and directly from a pseudorabies stage V area or an area or country recognized by the United States department of agriculture, animal plant health inspection service, veterinary services as pseudorabies free; or
 - (b) Originate immediately and directly from a pseudorabies stage IV area: and
 - (c) Be negative to an official pseudorabies test within thirty days of the exhibition.

901:1-18-11 Llama.

- (A) Camelids including, but not limited to, llamas, alpacas and vicuanas moved within Ohio for exhibition when presented for exhibition must show no symptoms or evidence of an infectious or contagious disease.
- (B) Camelids including, but not limited to, llamas, alpacas and vicuanas imported into Ohio for exhibition:
 - (1) Must be accompanied by a certificate of veterinary inspection issued within thirty days preceding the opening date of the exhibition and be identified with official individual identification.
 - (2) When presented for exhibition must show no symptoms or evidence of contagious disease.

OHIO'S LIVESTOCK TAMPERING EXHIBITION RULES

901-19-01 Definitions.

As used in Chapter 901-19 of the Administrative Code:

- (A) "Accessory reproductive tissue" includes but is not limited to epididymis.
- (B) "Agricultural society" or "society" means a county agricultural society or an independent agricultural society that is organized under the laws of the state of Ohio.
- (C) "Approved" when used in reference to drugs, means approval by the United States food and drug administration for use in the species indicated on the label.
- (D) "Breed show or class" means a show or class limited to breeding stock of a specific breed of livestock.
- (E) "Class" means a division within a show or exhibition as defined by a sponsor.
- (F) "Department" means the department of agriculture created under section 121.02 of the Revised Code.
- (G) "Designee" when used in reference to an exhibitor, means a member of the exhibitor's family or household or any other registered or authorized representative of the exhibitor.
- (H) "Director" means the Ohio director of agriculture appointed pursuant to section 121.03 of the Revised Code.
- (I) "Drenching" means the act of using an instrument, including a bottle, placed in an animal's mouth to orally administer a liquid, food, or any other substance.
- (J) "Drug" means drug as defined in division (C) of section 4729.02 of the Revised Code and its metabolites.
- (K) "Drug use notification form" means the document completed in accordance with rule 901-19-06 of the Administrative Code.
- (L) "Exhibition drug residue legal" means an animal has not been administered a drug; or if administered a drug the withdrawal period has elapsed at the time the drug use notification form is completed.
- (M)"Exhibitor" means any person who shows, displays, or exhibits livestock at an exhibition.
- (N) "Extra label use" means the actual or intended use of a drug in livestock in a manner other than in accordance with the drug label directions.

- (O) "Fair" means the annual exhibition held by the Ohio expositions commission, pursuant to division (A)(1) of section 991.03 of the Revised Code, or a county agricultural society or independent agricultural society, as reported to the director pursuant to rule 901-5-11 of the Administrative Code.
- (P) "Family" means the immediate family of an exhibitor, including but not limited to the exhibitor's parent, step-parent, foster parent, grandparent, step-grandparent, foster grandparent, brother, sister, step-brother, step-sister, half-brother, half-sister, son, daughter, step-son, step-daughter, or guardian.
- (Q) "Grand champion" means the highest placing livestock entry of a show.
- (R) "Household" means the permanent residence address of the exhibitor.
- (S) "Immediately" means the time period between the cessation of administration of a drug and the point at which drug residues in the livestock are within tolerance levels or at zero tolerance, unless a safe level has been established by the United States food and drug administration.
- (T) "Internal rule" means any rule adopted by a sponsor or applicable to the sponsor's exhibition and includes all mandatory rules and those optional rules from which the sponsor does not exempt itself or its exhibition.
- (U) "Junior livestock show" means a show limited to exhibitors nine years of age or in the third grade through nineteen years of age, or as authorized to participate in either 4-H, FFA, or other youth organization.
- (V) "Label" means the attached label or the accompanying brochure that lists the approved species, dose, route of administration, withdrawal time and any cautionary statement; a prescription label; the requirements of labeling for an extra label use drug as permitted by the United States food and drug administration; and information provided by the food animal residue avoidance databank (FARAD).
- (W)"Licensed livestock facility" means a livestock facility licensed pursuant to Chapter 943. of the Revised Code or a similar law of another state.
- (X) "Mandatory rule" means any rule adopted by the director relating to food safety or the health, safety, or welfare of livestock and from which a sponsor may not exempt itself or its exhibition.
- (Y) "Market flock style project" means ownership including an individual junior exhibitor, family of a junior exhibitor or a cooperative made up of junior exhibitors. Through this type of ownership, the junior exhibitor(s) are to care for, groom, and select any and all birds to be used in exhibitions as well as actively participate in any decision-making processes for the flock.
- (Z) "Market livestock" means exhibition livestock bred, raised and intended for slaughter for food purposes.
- (AA) "Market poultry" means birds including, but not limited to, meat chickens, turkeys, geese and ducks.
- (BB) "Non-terminal show" means a show in which no livestock is required to be slaughtered.

- (CC) "Optional rule" means any rule adopted by the director from which a sponsor may exempt itself or its exhibition.
- (DD) "Outstanding market project" means the exhibitor ranking highest in the outstanding market project competition in a show.
- (EE) "Over the counter drug" means any drug that lawfully may be purchased without a prescription.
- (FF) "Partial terminal show" means a show in which no fewer than the grand champion and reserve grand champion in each show or market class of livestock are sent directly to slaughter or to a licensed livestock facility no later than or immediately following the conclusion of the exhibition.
- (GG) "Prescription" means prescription as defined in division (G) of section 4729.02 of the Revised Code.
- (HH) "Quarantine" means isolation pursuant to section 941.07 of the Revised Code.
- (II) "Reserve grand champion" means the second highest placing livestock entry of a show.
- (JJ) "Residue" means residues as defined in division (I) of section 941.01 of the Revised Code.
- (KK) "Show" means that part of the exhibition restricted to exhibiting a single species and category of livestock such as, by way of example, but not limited to, market steer, dairy goats and market lambs.
- (LL) "Slick clipping" or "body shaving" means having hair that is less than one half inch in length on the body of market hogs.
- (MM) "Terminal show" means a show in which all livestock entered in the show are sent directly to slaughter or to a licensed livestock facility no later than or immediately following the conclusion of the exhibition.
- (NN) "Tolerance level" means the detectable level of a residue or other substance in livestock, in a livestock test sample, or in food, as that word is defined in division (A)(2) of section 3715.01 of the Revised Code, in a level less than or equal to the maximum level determined to be safe, acceptable or non-violative by the United States food and drug administration.
- (OO) "Unlawful substance" means any of the following:
- (1) Any drug prohibited by division (E)(1)(b) of section 901.76 of the Revised Code; or
- (2) A substance which is not normally found in or does not naturally occur in livestock; or
- (3) A substance which is normally found in or does naturally occur in livestock, but is detected or discerned in an amount or area greater than normal; or
- (4) Any drug required to be listed, but which is not listed on a drug use notification form; or

- (5) Any drug present in an animal regardless of how the drug came to be present if the drug was not administered under paragraph (A), (B) or (C) of rule 901-19-04 of the Administrative Code.
- (PP) "Veterinarian" means any person licensed to practice veterinary medicine under Chapter 4741. of the Revised Code or under the similar laws of another state.
- (QQ) "Withdrawal period" or "withdrawal time" means the interval from the time livestock is removed from medication until all residues are within the tolerance level.

901-19-02 Types of shows; slaughter.

- (A) The sponsor of an exhibition shall designate each of the shows held at the exhibition as one of the following types: terminal show, partial terminal show, or non-terminal show.
- (B) All of the following junior livestock shows or classes at a fair must be terminal shows or partial terminal shows unless at least thirty days prior to the opening of the show, the sponsor has submitted a written request to exempt a show from this provision, and the director has provided written authorization granting this request prior to the start of the fair:
- (1) Market beef steer;
- (2) Market hog;
- (3) Market lamb;
- (4) Market dairy steer;
- (5) Veal Calf; and
- (6) Market Goat.
- (C) All livestock which participate in a terminal show shall be consigned to slaughter either at the conclusion of the show or immediately following the exhibition.
- (D) In a partial terminal show at least the grand champion and the reserve grand champion shall be slaughtered. Prior to the show, the sponsor of the exhibition may require that additional livestock from a partial terminal show shall be slaughtered. The livestock shall be consigned to slaughter either at the conclusion of the show or immediately following the exhibition.
- (E) All livestock required to be slaughtered under this rule shall be slaughtered at a meat establishment either licensed by the department or granted inspection by the United States department of agriculture.
- (F) Notwithstanding paragraphs (B), (C) and (D) of this rule, livestock required to be slaughtered under this rule may, at the option of the sponsor of the exhibition, be consigned to a licensed livestock facility for sale provided that:

- (1) The livestock is consigned either at the conclusion of the show or immediately following the exhibition; and,
- (2) The livestock is sold only for slaughter.
- (G) From the beginning of the exhibition until departure for slaughter or consignment to a licensed livestock facility, the exhibitor or the exhibitor's designee shall be responsible for caring for the livestock.
- (H) Livestock destined for slaughter or consignment to a licensed livestock facility shall not be removed from the exhibition grounds until the livestock is transported to slaughter, to the licensed livestock facility, or until the sponsor approves movement of the livestock to another secure area for:
- (1) Disease control in accordance with paragraph (B)(4) of rule 901:1-18-03 of the Administrative Code; and
- (2) Quarantine for residue to allow a withdrawal time as determined by the approved fair veterinarian or in accordance with the instructions listed on the drug use notification form to elapse and may be subject to testing.
- (I) All livestock destined for slaughter shall be subject to testing by the director in accordance with section 901.73 of the Revised Code.
- (J) Livestock carcasses passing inspection may be released for normal disposition.
- (K) During inspection or testing, if the livestock carcass is preliminarily determined to have been tampered with or found to contain an unlawful substance, one of the following shall occur:
- (1) If the livestock carcass must be trimmed or reconditioned to comply with the meat inspection requirements, the carcass shall be trimmed and reconditioned and released to the exhibitor, unless the successful bidder accepts the trimmed or reconditioned carcass.
- (2) If the livestock carcass cannot be trimmed or reconditioned, it shall be condemned in accordance with the meat inspection requirements.
- (L) Livestock entered in or eligible for a carcass contest prior to or during a terminal, partial terminal or non-terminal show must be exhibition drug residue legal at the time of show and eligible for immediate slaughter.
- 901-19-03 Auction sales at terminal or partial terminal shows.

- (A) A sponsor may hold an auction sale of livestock exhibited at a terminal or partial terminal show.
- (B) An exhibitor who exhibits livestock at a terminal show or partial terminal show consents to participating in the subsequent auction sale.

- (C) All bidders at an auction sale following a terminal show or partial terminal show consent to the slaughter of the livestock or delivery to a licensed livestock facility.
- (D) Title to livestock sold at an auction sale and subsequently presented for slaughter or sale at a licensed livestock facility shall remain vested in the exhibitor. If the exhibitor is not the owner, the title to the livestock shall remain vested in the owner until the livestock has been passed by inspection and released in accordance with paragraphs (K)(1) and (K)(2) of rule 901-19-02 of the Administrative Code and passes all testing performed by or at the direction of the department or the sponsor.
- (E) At the discretion of the sponsor, the sponsor may collect the sale proceeds from the successful bidder and retain the proceeds until the carcass of the livestock has been released, or may allow the successful bidder to withhold payment of the proceeds until the carcass is released. In the event the carcass is not released, the sponsor shall return the sale proceeds to the successful bidder.
- (F) Prior to the auction, the sponsor shall announce the identification of the exhibition livestock which have been administered drugs for which the withdrawal time has not elapsed.

901-19-04 Prohibited practices.

This is a mandatory rule.

No person shall:

- (A) Administer or cause or permit to be administered a prescription drug to livestock either immediately before an exhibition or during an exhibition unless the prescription drug is administered:
- (1) By or under the supervision and direction of a veterinarian;
- (2) Only in accordance with label directions;
- (3) In conjunction with a valid veterinarian-client-patient relationship;
- (4) For a valid medical purpose; and,
- (5) A drug use notification form is completed and filed in accordance with the applicable requirements of rule 901-19-06 of the Administrative Code.
- (B) Administer or cause or permit to be administered an over-the-counter drug to livestock either immediately before an exhibition or during an exhibition unless the over the counter drug is administered:
- (1) By or under the supervision or direction of the exhibitor, the exhibitor's designee, the owner of the livestock or a veterinarian;
- (2) Only in accordance with label directions;
- (3) Only for a valid medical purpose; and,

- (4) A drug use notification form is completed and filed in accordance with the applicable requirements of rule 901-19-06 of the Administrative Code.
- (C) Administer or cause or permit to be administered either a prescription drug or an over the counter drug other than in accordance with the drug's label directions unless extra label use of the drug is:
- (1) By or under the supervision and direction of a veterinarian;
- (2) Only in accordance with the extra label directions provided by the veterinarian;
- (3) In conjunction with a valid veterinarian-client-patient relationship;
- (4) For a valid medical purpose;
- (5) A drug use notification form is completed and filed in accordance with the applicable requirements of rule 901-19-06 of the Administrative Code; and,
- (6) An extended withdrawal time is assigned to the drug by the veterinarian as part of the extra label directions and reported on the drug use notification form.
- (D) Show, sell, or offer for sale any livestock which contains an unlawful substance or has been subjected to unacceptable practices as outlined in rule 901-19-03 of the Administrative Code.
- (E) Show any livestock which contains a drug in an amount which exceeds the tolerance level if established or safe level; or, a drug for which the withdrawal period has not elapsed unless administered in accordance with paragraph (A), (B) or (C) of this rule.
- (F) Sell or offer for sale in an auction at a terminal or partial terminal show an animal that contains a drug in an amount which exceeds the tolerance level if established or safe level; or, a drug for which the withdrawal period has not elapsed unless administered in accordance with paragraph (A), (B) or
- (C) of this rule.
- (G) Exhibit an animal which has been tranquilized.
- (H) Make a false statement on a drug use notification form.
- (I) Fail to file or update a drug use notification form as required by 901-19-06 of the Administrative Code.
- (J) Negligently cause an unlawful substance to be present in an animal.
- (K) Fail to sign a chain of custody form.
- (L) Violate a mandatory rule.
- (M) Violate any optional rule from which a sponsor or exhibition did not exempt itself.
- (N) Fail to render assistance as provided by section 901.73 of the Revised Code.

901-19-05 Responsibilities of an exhibition sponsor.

- (A) Every sponsor of an exhibition shall appoint a person as its records official. The records official shall receive and maintain the drug use notification forms filed under rule 901-19-06 of the Administrative Code.
- (1) The records official shall reject any drug use notification form that is incomplete, illegible or unsigned. At the close of the exhibition the records official shall turn over the drug use notification forms received by him to the sponsor.
- (2) The sponsor shall maintain all drug use notification forms for a period of one year from the close of an exhibition. The drug use notification forms shall be made available to the department for inspection and copying upon request.
- (3) Review the submitted drug use notification forms prior to the show for compliance with paragraph (I) of rule 901-19-06 and rule 901-19-07 of the Administrative Code.
- (4) Review the submitted drug use notification forms for compliance with paragraph (B) of rule 901-19-38 of the Administrative Code if applicable.
- (B) The sponsor of an exhibition shall provide information requested by the director on a form prescribed by the director at least ten days before the start of the exhibition.
- (C) Prior to the start of an exhibition, the sponsor shall establish a method of identifying each animal in
- a terminal, partial terminal, and non-terminal show and maintain a chain of custody for each market livestock animal from the show through consignment to either slaughter or a licensed livestock facility for sale. The sponsor shall maintain a record of the identity of each animal and its chain of custody for a period of one year from the date of the last day of an exhibition.
- (D) All county and independent agricultural societies and the Ohio expositions commission shall print Chapter 901:1-18 of the Administrative Code (Ohio's livestock health exhibition rules) in their premium book for the current year.
- (E) The sponsor of a county or independent agricultural society or the Ohio exposition commission shall provide a livestock exhibitor or an adult advisor, upon request, a copy of Chapter 901-19 of the Administrative Code and print in their current premium book the following notice:
- "Chapter 901-19 of the Administrative Code (Ohio's livestock tampering exhibition rules) will be made available to a livestock exhibitor or an adult advisor, upon request."
- (F) The sponsor may elect to include the entire text of chapter 901-19 of the Administrative Code within their premium book.

(G) All other exhibitions shall provide to exhibitors, upon request, a copy of Chapters 901:1-18 and 901-19 of the Administrative Code and shall include the following statement in at least one written announcement prior to the beginning of the exhibition:

"The exhibition's management will provide, upon request of an exhibitor, a copy of Chapters 901:1-18 (Ohio's livestock health exhibition rules) and 901-19 (Ohio's livestock tampering exhibition rules) of the Administrative Code.

901-19-06 Drug use notification.

- (A) The exhibitor and the owner of an animal are jointly and severally responsible for completing and filing out the drug use notification form in the manner required by this rule.
- (B) The drug use notification form shall be signed by either the exhibitor or the owner. If the person signing the form is a minor child, the form shall be cosigned by a parent or guardian of the minor child.
- (C) A drug use notification form shall be completed for every animal from which a test sample is collected at every terminal and partial terminal or non-terminal show, and for every animal that is administered a drug either immediately before or during an exhibition.
- (D) The director shall require a drug use notification form to be completed for the following livestock exhibited in a junior livestock show:
- (1) Market steer;
- (2) Market hog;
- (3) Market lamb;
- (4) Veal calf;
- (5) Market dairy steer;
- (6) Market goats;
- (7) Market poultry;
- (8) Lactating dairy cattle; and
- (9) Lactating goats.
- (E) The drug use notification form shall be filed with the records official prior to the show in which the animal is entered.
- (F) The director may require a drug use notification form to be completed for livestock exhibited at any type of show including a non-terminal show.

- (G) If the information on the form regarding drug use changes or if a drug is subsequently administered at any time after the drug use notification form is filed, an updated drug use notification form shall immediately be filed with the records official.
- (H) No person shall submit an incomplete, illegible or unsigned drug use notification form.
- (I) When a drug use notification form submitted to a records official for livestock is incomplete, illegible, or unsigned neither the exhibitor nor the owner shall, until the defect is corrected:
- (1) Receive any prizes or awards from shows in which the livestock was exhibited prior to the time the drug use notification form was to be filed.
- (2) Participate in any shows or sales held subsequent to the time the drug use notification form was to be filed.

901-19-07 Quality assurance.

This is a mandatory rule.

- (A) Except as stated in paragraph (B) of this rule, sponsors shall require exhibitors at fairs sponsored by county or independent agricultural societies or the Ohio exposition commission to annually attend or complete a quality assurance program sponsored and conducted cooperatively by the exhibition sponsor, Ohio state university extension, Ohio agricultural education, or agricultural commodity organizations.
- (B) At the discretion of Ohio state university extension, or Ohio agricultural education, an exhibitor may pass a test based on the appropriate skill level for their age (twelve to fourteen or fifteen to eighteen) under the supervision of Ohio state university extension or Ohio agricultural education before exhibiting terminal or partial terminal market livestock, including market poultry, lactating dairy cattle and lactating goats in a junior livestock show. Youth who pass the test will be exempt from annual quality assurance re-certification until they move to the next age bracket or they are no longer a junior exhibitor (nineteen years of age or older on January first of their last year). Minimum standards for youth food animal quality assurance are as set forth in appendix A to this rule.
- (C) Exhibitors who fail to attend or complete a quality assurance program or fail to pass the exam as outlined in paragraph (B) of this rule may be subject to the disciplinary actions listed in rule

901-19-21 of the Administrative Code.

901-19-09 Drug residues in non-terminal show animals.

- (A) A person may, notwithstanding paragraph (E) of rule 901-19-04 of the Administrative Code, show at a non-terminal show an animal which has been administered a drug provided they are in compliance with all of the following:
- (1) The drug is a prescription drug or an extra label use of a drug and the drug is prescribed by a veterinarian pursuant to a valid veterinarian-client-patient relationship;

- (2) The drug is administered or used only in accordance with label directions or the prescription;
- (3) The drug is administered or used only for medical purposes; and,
- (4) A drug use notification form is completed and filed in accordance with the applicable requirements of rule 901-19-06 of the Administrative Code.
- (B) Milk or other food obtained from livestock which has been administered or treated with a drug and permitted to exhibit pursuant to paragraph (A) of this rule, shall not be used for human consumption.

901-19-10 Testing requirements and test results.

This is a mandatory rule.

- (A) Urine, blood, tissue and other test samples shall be collected in accordance with the department's protocol for the collection of livestock test samples at exhibitions. Test samples may be collected before, during, or immediately after a show. Deviation from the protocol shall be noted.
- (B) The director may at his discretion, collect any urine, blood, tissue, or other test samples from exhibition animals at the time of slaughter.

901-19-11 Humane treatment of livestock.

This is a mandatory rule.

- (A) A person shall treat livestock in a humane manner and in accordance with acceptable commercial practices so as to protect the health, safety, and welfare of the livestock.
- (B) All exhibitors shall comply with and abide by the policy statement and "code of practices" of the Ohio livestock coalition.

901-19-12 Acceptable practices.

This is a mandatory rule.

The following practices are deemed acceptable to protect and promote the health, safety, and welfare of livestock:

- (A) Adding caffeine free soda pop, gelatin, or other sweeteners to drinking water in nominal amounts to encourage water consumption;
- (B) Hoof trimming;
- (C) Cosmetic dehorning in market class livestock;
- (D) Using collodion as a teat sealant, but for no longer than eighteen hours;
- (E) Adding molasses or other sweeteners to feed to encourage consumption;

(F) Properly administered and approved growth implants;
(G) Castration;
(H) Beak trimming;
(I) Dehorning;
(J) Tattooing;
(K) Hot or freeze branding;
(L) Humane ringing;
(M)Tail docking;
(N) Ear notching;
(O) Ear tagging;
(P) Shearing;
(Q) Drenching of livestock for a medical condition at an exhibition when diagnosed by a licensed veterinarian;
(R) Acceptable surgery, including clamps, bands and chemical castration; and
(S) Application of ice, ice packs, cold packs, or cold compresses prescribed to relieve heat stress or a medical condition diagnosed by a licensed veterinarian at an exhibition.
901-19-13 Unacceptable practices.
This is a mandatory rule.
The following practices are detrimental to the health, safety, and welfare of livestock and are prohibited:
(A) Applying any electrical, mechanical, or other appliance to livestock repeatedly or for a prolonged time period in violation of 9 C.F.R. 313.2 (1979);
(B) Hitting, striking, beating, or otherwise impacting livestock that induces swelling or enhances, transforms or changes the true conformation, configuration, or appearance of the livestock;
(C) Applying any electrical, mechanical, or other appliance that enhances, transforms, or changes the true conformation, configuration, or appearance of the livestock, unless prescribed by the exhibition veterinarian;
(D) Plugging of teats;
(E) Sealing of teats using unapproved substances or for longer than eighteen hours using approved substances;

- (F) Injecting material into udders or teats for non-medical purposes or otherwise artificially modifying the appearance or conformation of the udder or teat;
- (G) Using ice, ice packs, cold packs, or cold compresses internally or externally other than in accordance with paragraph (S) of rule 901-19-12 of the Administrative Code;
- (H) Using a stomach tube or pump for any purpose other than for the relief of tympany or gas on the day of exhibiting;
- (I) Drenching of livestock at an exhibition is prohibited except as permitted under paragraph (Q) of rule 901-19-12 of the Administrative Code.

901-19-19 Absolute liability.

This is a mandatory rule.

- (A) Both the exhibitor and the owner of livestock are absolutely liable to discipline under rule 901-19-21 of the Administrative Code for the presence of an unlawful substance in livestock and unacceptable practices done to livestock.
- (B) If the exhibitor or the owner was a minor child at the time the unlawful substance or unacceptable practice was detected, the parent or guardian of the person shall also be absolutely liable to discipline under rule 901-19-21 of the administrative Code for the presence of an unlawful substance in livestock and unacceptable practices done to livestock.
- (C) The director or the sponsor when imposing discipline under paragraph (A) of this rule upon a person, may mitigate the discipline imposed based upon one or more of the following facts if established.
- (1) The person did not introduce the unlawful substance into the animal or do any unacceptable practices to the livestock;
- (2) The person had no actual or constructive knowledge that the unlawful substance was introduced into the livestock or that unacceptable practices had been done to the livestock;
- (3) The unlawful substance was not introduced into the livestock and the unacceptable practices were not done to the livestock through the person's negligence.

901-19-21 Disciplinary action.

- (A) Any person who violates a provision of sections 901.70 to 901.76 of the Revised Code or any provision of this chapter is subject to any of the following disciplinary actions:
- (1) Disqualification from any exhibition;
- (2) Disqualification of the exhibition livestock from any exhibition;

- (3) Continuing education;
- (4) Written letter of reprimand;
- (5) Forfeiture or return of awards, prizes, premiums, or proceeds; or
- (6) Pre-exhibition drug testing.
- (B) Disqualification may include any or all shows and classes and may be for any number of years.
- (C) Anyone who violates rule 901-19-07 of the Administrative Code may be given a letter of reprimand for the first offense.
- 901-19-31 Responsibilities of and assistance to junior fair exhibitors.

This is an optional rule,

- (A) A junior livestock show exhibitor shall be responsible for the continuous care, grooming, and preparation of the livestock entered in the junior livestock show.
- (B) An exhibitor may receive assistance in the care, grooming, and preparation of the livestock entered in the junior livestock show, provided that the assistance shall be limited to explanation or demonstration provided by the following:
- (1) Family members;
- (2) Household members;
- (3) Advisors or adult volunteers of 4-H or FFA in the exhibitor's club or county;
- (4) Vocational agriculture instructors;
- (5) County extension agents;
- (6) Department representatives;
- (7) Veterinarians;
- (8) Members of the exhibitor's 4-H club, FFA chapter, or other youth organizations; and
- (9) Guest speakers of the 4-H, FFA, or other youth organizations.
- (C) Any person not specified in paragraph (B) of this rule who provides assistance to a junior livestock show exhibitor shall register in writing with the sponsor. The responsibility to register rests with the exhibitor. An assistant may register for more than one exhibitor. Failure to register constitutes grounds for disciplinary action against the exhibitor. Assistance shall be limited to explanation and minimal demonstration.

901-19-32 Breed shows or classes.

This is an optional rule, we do not opt in or enforce this rule.

Unless otherwise modified by a mandatory rule, the rules of the breed association shall be accepted grooming practices for that particular breed's show or class.

901-19-33 Prohibited grooming practices.

This is a mandatory rule.

The following grooming practices are prohibited in junior market livestock shows unless those grooming practices are permitted under rule 901-19-32 of the Administrative Code:

- (A) Using any substance to enhance or change the color of the livestock, including the livestock's hide or hooves;
- (B) Adding any substance externally to build up, change or alter the shape or conformation of the livestock, including by way of example but not limited to rope, false hair, graphite, hemp, and powders;
- (C) Pigmented grooming aides or materials; and
- (D) Slick clipping or body shaving of market hogs except on the ears and tails.
- 901-19-34 Outstanding market project competition.

This is an optional rule, we do opt in and enforce this rule.

An exhibition may provide for an outstanding market project competition in one or more classes. The competition may include an evaluation of the livestock, demonstration of the exhibitor's showmanship abilities, or a skillathon or interview judging. The skillathon or interview judging may include demonstration of the exhibitor's knowledge of quality assurance principles, as set forth in an industry publication or in a publication such as the "caring for animals" handout or by viewing the "caring for animals video" available from a county extension office.

901-19-35 Recognition of disciplinary actions.

This is an optional rule, we do opt in and enforce this rule.

- (A) Disciplinary action by a sponsor against a person for a violation of sections 901.70 to 901.76 of the Revised Code or Chapter 901-19 of the Administrative Code shall be given full faith and credit and shall be honored at all exhibitions.
- (B) A person who has been convicted of violating sections 901.70 to 901.76 inclusive of the Revised Code shall be prohibited from participating in any exhibition for a minimum period of three years.
- 901-19-38 False, deceptive or unacceptable practices.

The following are unacceptable practices:

- (A) Castration of livestock for purposes of this rule which exceed the following criteria:
- (1) Cattle over eight months of age;
- (2) Swine over seventy-five pounds; or
- (3) Sheep over seventy-five pounds.
- (B) Showing any market livestock which has been treated in accordance with paragraph (A), (B) or
- (C) of rule 901-19-04 of the Administrative Code when a side effect of the drug conceals, enhances, transforms, or changes the true conformation or condition of the livestock.
- (C) Any natural occurrence or surgical process which results in testicular tissue remaining in the body of exhibition livestock except rabbits and poultry.
- 901-19-39 Ownership requirements.
- (A) No exhibitor shall register, enter, or exhibit in a junior livestock exhibition any of the livestock listed in paragraphs (A)(1) to (A)(7) of this rule unless the household, as defined in paragraph (R) of rule 901-19-01, at which the exhibitor is registered at has owned the livestock for not less than the length of time listed:
- (1) Market steers one hundred fifty days;
- (2) Market dairy steers one hundred fifty days;
- (3) Market hogs sixty days;
- (4) Market lambs sixty days;
- (5) Market goats sixty days;
- (6) Veal calves sixty days; and
- (7) Market poultry within five days of hatch including all individual participants in a cooperative.
- (B) No exhibitor shall register, enter, or exhibit livestock in a junior breeding livestock exhibition unless the household, as defined in paragraph (R) of rule 901-19-01, at which the exhibitor is registered at has owned the livestock or has had the livestock registered under the exhibitor's name for at least sixty days.
- (C) For any exhibition other than those listed in paragraphs (A)(1) to (A)(7) and paragraph (B) of this rule, the length of time a person shall own livestock before the person may register, enter, or exhibit the livestock at an exhibition may be set by either the sponsor of the exhibition or a breed association.
- 901-19-40 Meetings of the advisory committee on livestock exhibitions.
- (A) Board meetings

A regular meeting of the committee shall be held at least once annually after the fifteenth day of October and before the first day of December. The committee may meet at other times as the chairperson or a majority of the committee members considers appropriate, provided the chairperson gives members written notice of any meeting at least seven days prior to the meeting.

(B) Notice of meetings

- (1) Regular meetings: Notice of all of the advisory board's regularly scheduled meetings, including date, starting time and location shall be sent to the committee members by either regular or electronic mail at least seven days prior to the meeting, and will be posted on the department's web site www.agri.ohio.gov and may also be provided to Gongwer or Hannah news service for website at least ten days in advance of all regularly scheduled meeting.
- (2) Special meetings: Notice of date, time, place, and purpose of any special meetings shall be placed on the department's website www.agri.ohio.gov and may also be provided to Gongwer or Hannah news service, as well as sent to media outlets that requested such information, at least twenty-four hours prior to said meeting.
- (3) Emergency meetings: Notice of date, time, location and purpose of all emergency meeting shall be given to all news media who requested prior notification, and on the department's website www.agri.ohio.gov.
- (C) Any person may obtain prior notice of the date, time, and location of any regularly scheduled, special, emergency, or any of the aforementioned meetings when a particular type of business is to be discussed by requesting prior notification in writing from the "Ohio Department of Agriculture, Office of Animal Health, 8995 East Main Street, Reynoldsburg, Ohio 43068"; or by calling the animal health division at (614) 728-6220.

UNIFORM RULES FOR 4-H HORSE SHOWS

The Uniform Rules are required for 4-H horse shows throughout the state of Ohio. In a horse program as large as Ohio, consistency of rules is very important for smooth operations of the program. However, we also realize that due to the variation in size and organization of the horse clubs, counties need the flexibility to add to these committees and/or the local shows. However, when the 4-H member comes to the state horse show, these rules will be strictly followed, or if changes are made to these rules they will be written out and given to all exhibitors.

The rules in this section are highlighted rules from the Uniform Rule Book for all to have access too, to have all the rules please contact the OSU Extension office to order or the OSU Extension website to order your own Uniform Rules Book.

Ownership: Equine used as project animals must either be owned by the member the member's family (step included) or leased. A horse can only be leased by one 4-H member

All animals carried as a project and those that are shown as the state fair must be owned or leased and in the continual care of the 4-H member by the date specified by the member's county. This date shall be no later than June 1st. Continual care does permit boarding an animal, provided the member is involved in caring for the horse and the horse is not a production animal. Project animals should not to switch during the year.

Knox County rules state that continual care for our fair is by May 1st.

All equine members will have a sheet in their record book to indicate care given by them for the project animal. These need to be kept up to date and be available for OSU, Fair board and Equine Committee during fair week.

General Rules:

No riding without proper tack and attire. No tank tops, no shorts, no tennis shoes! Helmets are required.

Inhumane (as determined by show manager) methods of schooling or showing are not allowed. Any fresh bleeding observed by the judge and caused by rider, tack or lack of control in a class disqualifies the exhibitor in that class.

Knox County Rules state that excessive use of crop or whip (determined by judge and/or show manager) will have one verbal warning. If excessive use is continued the rider will be disqualified from that day's events.

Administration of any drug (including herbal preparations) that affects the central nervous system (stimulant or depressant) to a horse shown in any 4-H class is strictly prohibited.

The Judge determines if a horse is sound or healthy enough to compete in a class.

The procedures for handling horse show complaints and protests are as followed:

- 1. Complaints are handled through the show steward, who clarifies rules and arranges for the exhibitor to visit with the judge if the steward feels the request is justified.
- 2. If any complaint cannot be resolved at the steward level a written protest should be filed with show manager
- Protests must be made in writing and signed by the party or parties making the protest.
- A \$100 fee must accompany the protest. The fee is retained by the show manager and used to pay the costs of investigating the protest.
- The protest and fee must be filed with the show manager the same day of the show. The protest is considered at the time designated by the show manager and includes the accused, the accuser and Extensions representative, and any other needed parties. If any party cannot attend, a representative must be sent.

A judge's decision on how a class is placed, or a decision on disqualification of an exhibitor based on the judges' interpretation of the rules for that class, shall not be protested.

The show manager has the right to prohibit an exhibitor from showing if there is evidence that the exhibitor has violated 4-H horse show rules that would make the exhibitor ineligible to show.

Because of animal welfare concerns and the image that 4-H wants to present, horses with a body condition score of less than 4, when using a scale of 1-9, obviously sick horses and horses with a Grade 3 or greater lameness are not allowed at 4-H shows, The show manager, fair vet if available, or the judge can dismiss a horse from the show for these reasons.

Versatility:

- 1. This competition is designed to motivate riders to broaden their horsemanship. It creates the opportunity for riders to develop new skills and to further train their horses. It is especially recommended for advanced riders.
- 2. This class consists of four separately shown and judged classes. One of the four classes should be a Western class, one should be an English class; one should be a Gymkhana class; and one should be a class in which exhibitors work individually (reining, trail, etc.). Exhibitors must complete all four classes to be eligible for final placing.

- 3. These are the conditions for entry; the exhibitor must have placed in a showmanship and/or horsemanship (equitation) class at this show prior to making an entry in the versatility. Definitive restrictions are to be determined by local advisors according to their county's level of achievement; these restrictions must be made before the show begins. It is suggested that versatility exhibitors should have completed two years of 4-H project work with horses.
 - a. Knox County allows all who are three-gaited to participate in Versatility and has added showmanship to the showbill
- 4. Each rider must show in all four events and must use the same horse in each event. Judges place each class 1-10. Points are totaled for all four classes to determine the winner.
 - a. Knox County requires all five classes
- 5. The winner of the Versatility Class is the horse and riders accumulating the most points in the four events combined and lower placings are similarly determined. In the event of a tie in the number of points, it is recommended that the exhibitor with the highest horsemanship/equitation score is the winner; however, counties may use their discretion on how to break ties.
 - a. Knox County requires all five classes and first tie breaker is highest Horsemanship points
- 6. All changes of tack and appointments must be made within the 5-minute intervals between events or the entry is eliminated.
 - a. Knox County allows extended time as it will work around miniatures showing in events between light horses

Gymkhana:

To start in the arena; the horse and rider may be assisted up to the entrance gate, but the horse and rider must enter the arena alone. The rider must not enter the gate any faster than a trot, must stop forward motion by completely stopping or else do a circle prior to starting the pattern.

A horse that runs into the wall or fence at any time due to lack of control or disobedience while in the arena will be disqualified.

The judge may assess a 5-second penalty for the rider who obviously has no control of his/her animal while doing the pattern and produces an unsafe ride.

RULES AND REGULATIONS FOR KNOX COUNTY FAIR EQUINE

General Rules:

- 1. All rules from the Ohio 4-H Uniform Rule book will be followed. The following rules are either to enforce or strengthen those rules set. Failure to complete with the rules in the Uniform Rule Book will result in disqualification or dismissal from class. Judge, ring steward and/or fair board have the right to excuse anyone from the arena at any time due to; safety, tack malfunction, unsportsmanlike conduct, and excessive use of spurs/whip or not in compliance with Ohio 4-H rule book.
- 2. All classes are open to Knox County 4-H and FFA horse and pony projects.
- 3. All State 4-H rules supersede all county rules
- 4. Non-Horse members of FFA are NOT permitted to ride any horse outside specific classes.
- 5. No riding double
- 6. Riding is permitted in arenas. You will lead horses to and from barns and around barn areas
- 7. You will be supportive of your fellow horseman, judges, advisors, fair board and parents. Unsportsmanlike conduct in any manner will result in following consequences;
 - a. Removed from day's events
 - b. Removed from fair week events
 - c. Removed from fair

d. Unable to show following year at fair

- 8. Members will be assigned back numbers and will be in effect the entire fair week. If two horses are being shown then two different numbers will be needed, one for each horse.
- 9. Lights out at 11:00pm UNLESS a proper cool down or arrangement has been made with Sr. Fair Board Chairman
- 10. Barns and stalls are to be kept clean! Horses will be properly cared for as grain and/or hay will be supplied as needed and clean water will always be available. If proper care does not seem to be occurring, please notify the Sr. Fair board Chair-man and barn supervisor before completely any care.
- 11. The horse you bring to fair is the horse you show at fair. Once that horse is on the fairgrounds it is the horse you show at the fair. You have until that time to bring your back-up. Horses are not permitted to leave fairgrounds on unauthorized days unless arrangements have been made PRIOR to the fair and all paperwork is turned in.
- 12. If a companion horse is needed for you horse the Sr fair board chairman, Jr fair coordinator, OSU representative and Fair Vet need to be contacted and meeting before consent will be given.
- 13. All records will be kept in the announcer's booth and recorded daily and sent to Jr. Fair Board office.
- 14. No smoking in barns! No substance abuse will be permitted.
- 15. All injuries or concerns for horse's health will be brought to the Sr. Fair board chairman or Barn Supervisor who will contact fairground vet. If injury or concern happens during the night; owner, barn supervisor and fair board will be notified. Please remember we as a fair are liable and the FAIR VET has to see the animal.
- 16. No sandals or bare feet while riding or in the wash bay area.
- 17. All volunteers, members and the public will wear proper footwear while handling horses. If working a show respectful attire is required.
- 18. Post complete and correct information on stall cards.
- 19. There will be a 2-minute gate call for ALL participants, failure to follow gate call will result in a disqualification from class, you will not be permitted to complete in that class. Time starts at first call for class.
- 20. Classes are broken down based on the number of years the member has shown a horse either through 4-H and/or state fair or by age of member. Senior division is 14 as of January first and over as of 2021. Junior division is 13 as of January first and under as of 2021
- 21. Any rail working classes with 10 entries or more will be split at the judge's discretion.
- 22. Five places will be awarded per class except contest challenge and versatility classes. High point awards will be given during certain areas and will be based on overall points awarded during show on one rider, one mount. If there is a tie for an award the following will be the order in which the tie will be broken;
 - i. Showmanship Score (unless contesting then will go straight to option B)
 - ii. Number of first places awarded
 - iii. Number of second places awarded
 - iv. Number of third places awarded
 - v. Overall ABC judging score
- 23. All Measurements are to be done by an advisor before the fair.

ABC Judging

Book judging will be done before fair

- o You will need to bring your equine book with specific area completed
- Completed record books
- o A picture of your horse (front and side)
- Feed tag

Club Introductions

- 1. Members will be introduced as a club.
- 2. Each club may choose whether they ride or walk through the lineup.
- 3. Clubs can choose attire. (club shirts are acceptable)

Hiring Judges

1. Knox County Fair Judges do not need to be certified judges. Although the majority of shows will have a certified judge if it is not needed the following regulations will be followed when hiring.

Cannot be an advisor, parent, 4-H member or trainer of 4-H members that have residents in Knox County

Child or self must be out of 4-H no less than 2 (two) years.

Knowledgeable in the area they will be judging.

A payment of 200.00 will be set for those judging who are not certified.

Working Shows during Fair:

1. Sign ups for Fair will be during Feb meeting. Any show that does not have anyone sign up for it will be cancelled from fair week. If during the week a show is not covered the show will be cancelled.

Draft Horse and Ponies:

- 1. To complete in the 4-H Draft Horse and Pony shows you need to be in the Knox Co. Draft Horse and Pony Club.
- 2. Any Horse or Pony needs to be mare of gelding unless weanling. Weanling can be a stallion.
- 3. 4-H members are eligible for open Hitch and Halter Show, signups are due before fair starts, please see fair book for registrations and information.

Walk-Trot Rules and Regulations:

- 1. If you participate in Walk-Trot classes, you are INELIGIBLE for 3-gaited classes. You may move up from walk-trot but can-not go backwards.
- 2. If a rider breaks into a canter during a walk-trot class they have 2 strides to bring the horse back down to a trot. If the rider is unable to correct the break in 2 strides they will be disqualified from the class. This is a one time event for each class, if participating in a pleasure or horsemanship class, participants may finish the class but will be out of the running for placing. If in a speed event a no time will be given.
- 3. Members may not have ridden 3 gaited classes at PAS qualifier or any show earlier in the season and show walk-trot at fair.
- 4. If you participate in walk-trot you are not permitted to compete in Contest Challenge or Versatility.
- 5. Walk trot classes are for 1st and 2nd year members, unless medically indicated. (Medical documentation should be provided to Equine Coordinators)

Dressage and English Rules

1. Bits Allowed in Dressage:

- a. In the Introductory, Training, First and Second Level Dressage Test, Snaffle bits are required. Some acceptable bits are those with;
 - i. Single-jointed or double-jointed mouthpieces.
 - ii. The racing "D" ring
 - iii. The "O" ring
 - iv. A snaffle with/without cheek

- v. The egg butt snaffle
- vi. Rubber snaffle
- vii. Un-jointed Dr. Bristol
- viii. Fulmer or French snaffle
 - ix. Loose-ring snaffle
- b. The use of illegal bits, such as Pelhams, twists and Kimberwicks will result in a disqualification.
- 2. A properly fitted cavesson, dropped flash, crescent or crossed noseband must be used in all Dressage classes.
- 3. Braiding is optional for all classes
- 4. Readers are optional. A reader must be provided or requested before entering the show ring.
- 5. A horse and rider who obtain a score of 65% or higher at the Knox County Fair the prior year must move up to the next level of test.
- 6. Riders may ride in only THREE (3) dressage tests
- 7. Western Dressage is shown in Western tack and attire. Any type of headstall with a Standard Western Bit, Snaffle Bit, Hackamore or bosal is acceptable for Western Dressage. A Western Cavesson is allowed.
- 8. A jump will be placed in the practice arena for members competing in jumping classes for that day.

Contesting Rules

- 1. CLUB T-SHIRTS ARE ALLOWED DURING CONTESTING SHOWS <u>EXCEPT</u> CONTEST CHALLENGE!
- 2. All rules for contesting bits follow that of the Uniform Rules for 4-H Horse Shows
- 3. If a timer malfunction occurs during the rider's event a re-run will be granted at the end of the class.
 - a. The rider will not be punished with added time on second run if only ONE obstacle is knocked over during run
 - b. In the event of a re-run during flags (timer malfunction or flag fell over) the rider will not have time added if ONE obstacle is knocked over and only a 5 second penalty if flag is missed in placing in the second bucket. If a flag is missed or not carried past the second/end barrel a no time will still be given.
- 4. Rider will be disqualified if pattern was run off course or the break of forward motion occurs
- 5. Riders will enter arena under control and are required to break forward motion (stop, turn, backing)
- 6. Barrels and Poles; there will be a 5 second penalty added for knocking over an obstacle
- 7. Stakes and Keyhole; a no time will be given if any obstacles are knocked over during this event.
- 8. Flags; there will be a 5 second penalty added if the rider picks up the flag but does stick it in the opposite bucket. A 5 second penalty will be added per obstacle (barrel and bucket are two obstacles) that is knocked over. A no time will be given if the rider does not pick up the flag or picks up the flag but does not carry it PAST the second/end barrel.
 - a. If the flag falls over before the rider can reach the bucket they will be granted a rerun.

Western Rules

- a. All rules for western style riding bits will follow that of the Uniform Rules for 4-H Horse Shows
- 2. Ranch Horse participants can not participate in Western Horse classes and vise versa
- 3. All entries must be worked at a walk, jog, and lope, both directions of the ring in a pleasure class

Ranch Rules

- 1. The exhibitor cannot show the same horse in Ranch Pleasure and Western Pleasure at the same show.
- 2. Horses should be shown as naturally as possible.
- 3. Ranch riding classes will be pattern only and use Ranch Riding Pattern D.
- 4. No silver, fake tails branded, or braided manes or hoof polish will be permitted in Ranch classes; if items are found on exhibitor/horse the 4-H member will be disqualified.

Reining Rules

1. Reining classes will be scored on Reining Pattern A, pattern is available; online, in pattern packet and in your Uniform Rule Book.

Small Equine:

1. Hunter/Jumper in hand must have nylon or leather halter (no show halters) and lead cannot have a chain.

2. Refusals

8. Off course

7. Failure to maintain consistent pace.

9. Fall of horse and/or exhibitor

- a. They should not touch the horse while jumping.
- b. The handler is not allowed to jump with the horse.
- c. Minimum age for a small equine is 3 years old.
- d. Causes for elimination in Hunters/Jumpers
- 1. Knockdowns
- 3. Bucking or kicking
- 4. Spooking or shying
- 5. Wringing of tail
- 6. Showing an obstacle to horse
- 2. Hunter-in-Hand: Will be judged on way of going and faults
- 3. Jumper-in-Hand: Will be judged on faults and time only
- 4. Handy Hunter Trail will be judged like a trail class but will include jumps. 3 refusals will result in dismissal and DQ from Handy Hunter Trail.

Contest Challenge Rules

- 1. There is a \$10 fee to compete in Contest Challenge
- 2. Riders must show in all 5 events to be in running for champion awards. Riders may scratch at any time during the show but will forfeit chances for overall awards at the end of night.
 - a. If a rider is injured during competition and is no longer able to perform they will be awarded any placing received but will be withdrawn from overall champion awards.
- 3. To participate in the Contest Challenge, you must participate in the contesting regular show day.
- 4. All riders will be present for tack inspection.
- 5. Before the show begins all riders WITH horses will be excused to the designated holding area and remain mounted or stand at horse's head. During this time rules, regulations and national anthem will be presented. When announcers excuse Jr division riders the Sr. division will be given running order and may begin warming up.
- 6. Riders are to return to the holding arena after they have completed their run until the announcer releases you. Once all competitors from your class are finished with their run you will be excused by the announcer to return to stalls. You must be in the holding arena before your class starts and while your class is competing.
 - a. Violation of this rule will result in riders not being allowed to compete or be disqualified from that class which will result in them being disqualified from overall champion awards.

- b. If showing another animal results in you needing to be late or leave the arena early will need to be cleared with Sr Fair Board Chair-man BEFORE the show starts.
- 7. Dress Code: exhibitors must wear a long sleeve collared shirt, jeans, riding boots and helmet. NO chaps or gloves permitted. Club shirts are NOT permitted for this show.
- 8. Food and drinks are permitted in the holding area.
- 9. At the end of the show there will be 10 placing per class per division of the show. There will also be the following overall placing; Grand Champion, Reserve Champion, First Runner-Up and Second Runner-Up. Ties will be broken by
 - a. Number of first placing
 - b. Number of second placing
 - c. Number of third placing
 - d. If tie remains the highest ABC score will determine the winner
- 10. The judge may evaluate any safety concerns and remove the animal from competition if necessary.
- 11. Any complaints or protests must be written and accompanied by 100.00 cash (non-refundable) and handed to the Sr. Fair Board Chairman.
- 12. NO ONE is permitted to confront the judge, anyone who does will be removed from the show
- 13. NO ONE outside assigned help is allowed in the Announcer Booth.
- 14. No times will be given during the show
- 15. Arena drags will be completed at the discretion of the judge.
- 16. All reruns will be run at the end of that class
- 17. If you fall off while in the arena you will be disqualified
- 18. In case of a contestant's being off pattern, the rider can correct the problem at that point and finish the pattern but is NOT allowed to re-start the pattern.
- 19. Contestants will be given a 1-minute gate call to enter the arena. If failure to enter the arena in that 1 minute they will be disqualified from that class.
- 20. Total number of competitors is 80.
- 21. If you are in walk-trot classes, you are ineligible for Contest Challenge.
- 22. An Unsportsmanlike conduct will be an automatic removal from the contest challenge show and forfeit of any awards received.
- 23. Decorations on horse are permitted if it does not interfere with vision or movement of the horse and rider.

Light Horse Versatility Rules:

- 1. There is a \$10 fee to compete in Versatility.
- 2. Riders must show in all 5 events to be in running for champion awards. Riders may scratch at any time during the show but will forfeit chances for overall awards at the end of night.
 - a. If a rider is injured during competition and is no longer able to perform they will be awarded any placing received but will be withdrawn from overall champion awards.
- 3. To participate in Versatility, you must participate in one showmanship class on Saturday move in.
- 4. All riders will be present for tack inspection.
- 5. Before the show begins all riders WITH horses will be excused to the designated holding area and remain mounted or stand at horse's head. During this time rules, regulations and national anthem will be presented. When announcer excuses Jr division riders the Sr. division will begin.
- 6. Riders are to return to the holding arena after they have completed their class until the announcer releases you. Once all competitors for the next class are in the arena the before class will be excused.
 - a. Violation of this rule will result in rider not being allowed to compete in that class
 - b. If showing another animal results in you needing to be late or leave the arena early will need to be cleared with the Sr Fair Board Chair-man BEFORE show starts.

- 7. Dress Code: exhibitors must wear a long sleeve collared shirt, jeans, riding boots and helmet. NO chaps or gloves permitted. You may wear English boots while in English class
- 8. Food and drinks are permitted in the holding area.
- 9. At the end of the show there will be 10 placing per class per division of the show. There will also be the following overall placing; Grand Champion, Reserve Champion, First Runner-Up and Second Runner-Up. Ties will be broken by
 - a. Highest Horsemanship score
 - b. Number of first placing
 - c. Number of second placing
 - d. If tie remains the highest ABC score will determine the winner
- 10. The judge may evaluate any safety concerns and remove the animal from competition if necessary.
- 11. Any complaints, or protests must be written and accompanied by \$100 cash (non-refundable) and handed to the Sr. Fair Board Chairman.
- 12. NO ONE is permitted to confront the judge, anyone who does will be removed from the show
- 13. NO ONE outside assigned help is allowed in the Announcer Booth.
- 14. No times will be given during the show
- 15. If you fall off while in the arena you will be disqualified
- 16. In case of a contestant's being off pattern, the rider can correct the problem at that point and finish the pattern but is NOT allowed to re-start the pattern.
- 17. Contestants will be given a 1-minute gate call to enter the arena. If failure to enter the arena in that 1 minute they will be disqualified from that class.
- 18. Total number of competitors is 80.
- 19. If you are in walk-trot classes, you are ineligible for Versatility.
- 20. An Unsportsmanlike conduct will be an automatic removal from the Versatility show and forfeit of any awards received.

Mini Versatility Rules

- 21. There is a \$10 fee to compete in Mini Versatility
- 22. Riders must show in 4 classes to be in the running for champion awards. Riders may scratch at any time during the show but will forfeit the chance for overall awards at the end of show.
- 23. Mini Versatility consists of the following classes
 - a. Showmanship
 - b. Trail-in-Hand
 - c. Jumper-in-Hand
 - d. Hunter-in-Hand

- e. Driving Reinsmanship
- f. Driven Trail
- g. Driving Pleasure
- h. Showmanship is a required class for mini versatility
- i. You will pick 3 other classes for those points to count towards overall showmanship is a must for points
- j. You may complete in all 6 classes but only points from chosen 3 and showmanship will count towards overall.
- 24. Dress Code: exhibitors must wear a long sleeve collared shirt, jeans, riding boots and helmet/western hat
- 25. At the end of the show there will be 5 placing per class per division of the show. There will also be the following overall placing; Grand Champion, Reserve Champion and First Runner-Up Ties will be broken by
 - a. Showmanship Score
 - b. Number of first placing
 - c. Number of second placing
 - d. If tie remains the highest ABC score will determine the winner
- 26. The judge may evaluate any safety concerns and remove the animal from competition if necessary.

- 27. Any complaints or protests must be written and accompanied by 100.00 cash (non-refundable) and handed to the Sr. Fair Board Chairman.
- 28. NO ONE is permitted to confront the judge, anyone who does will be removed from the show
- 29. NO ONE outside assigned help is allowed in the Announcer Booth.
- 30. No times will be given during the show
- 31. Contestants will be given a 2-minute gate call to enter the arena. If failure to enter the arena in that 2 minutes they will be disqualified from that class.
- 32. An Unsportsmanlike conduct will be an automatic removal from the mini versatility show and forfeit of any awards received.

Open Pee Wee Class General Rules

- 1. Participants must be 2 through 8 years of age.
- 2. Must be led by a Knox County 4-H horse exhibitor.
- 3. Helmet is required!

Cloverbud Participants

1. Participants must be 5 through 8 years of age and enrolled in kindergart

Knox County Fair Equine Class Descriptions

Dressage/English/Jumping

- 1. These are a systematic, gymnastic form of training horses. Dressage tests are an examination of how well a horse and rider can perform a prescribed set of maneuvers. The "tests" consist of performing halts, sitting trots, canters and working walks and trots. Dressage Tests may be memorized or read to the rider by a caller.
 - a. Introductory Test A (First Time Rider Only) is a walk-trot test which is open to the rider who has NEVER shown Dressage before (regardless of age/year in 4-h).
 - b. This rider may enter Intro B/C if they wish
 - c. Riders may choose to ride in NO MORE than 3 Dressage Tests
 - d. Higher Tests may be ridden upon request
- 2. Dressage Equitation is judged on the rider's dressage-style hands, legs and body posture at a walk, rising trot, sitting trot and canter.
 - a. Intro A and B are walk-trot tests that are good for the beginner dressage rider and/or horse. These tests can be entered by walk-trot members and 3-gaited members but have limited dressage experience or an inexperienced horse.
- 3. Prix Caprilli: is a combination of low fences and dressage test. Walk, trot, canter and Jump.
- 4. Flat Classes: A rider may show in one class in each of the equitation and pleasure divisions. Balance Seat Equitation is an additional class which can be ridden in addition to English Equitation.
- 5. Pairs Class: is judged on the teamwork of two horses and riders, it is not necessary that the horses be matched in appearance, but they do need to work as a unit. This is a fun class to ride and watch.
- 6. English Pleasure: is a class for horse/pony, which is ridden in any kind of English saddle. In this class, the judge is looking for a horse that appears to be pleasurable to ride with a "ground-covering" way of going.
- 7. Ground Pole Equitation: is a class for riders who are learning to jump. It is judged on the rider's hands, seat, guidance and control of horse over a series of ground poles arranged in a simple course. This is considered a walk-trot class but is not limited to only walk-trot members.
- 8. Ground Poles Working Hunter: is a beginner class which is judged on the performance, manners and style of the horse/pony.
- 9. Handy Hunter Trail: is a trail class with obstacles and small fences to jump. This class is open to all members.

Western

Ranch: A superior ranch riding horse has a free-flowing stride of reasonable length in keeping with his conformation and covering a reasonable amount of ground as if he was going across the pasture to do a task on the ranch in a timely fashion. Horses should not be a run away but "we" have a lot to do today. Ideally, he should have a balanced, flowing motion, while exhibiting correct gaits with proper cadence and rhythm. The quality of the movement and consistency of the gaits is a major consideration.

Contesting Class Patterns: Pattern book is handed out each year and available on website with measurements and descriptions.

Fun Show Description

- 1. Costume Class: Kids may dress themselves and their horse in appropriate costumes, if it can not be worn, said or displayed in a school is it not permitted in the arena.
- 2. **Roping**: is to use a rope of their choice and will be given three (3) attempts at roping a dummy.

- 3. **Tying:** competitors are timed from a line as he rides his horse to the object "to be tied", dismounts and throws and ties it and holds up their hands. The tie will then be inspected. There are mounted and unmounted tying events.
- 4. Pee Wee Showmanship: Kids between the ages of 2-7 or 8 and not in 4-H can enter this class with a member or parent who is comfortable with the horse.
- 5. Pee Wee Lead in: Kids between the ages of 2-7 or 8 and not in 4-H can enter this class riding a horse with a member or parent who is comfortable with the horse
- 6. Jack Benny Lead in Barrels: anyone over the age of 19 that needs to be led by a member or other person comfortable with the horse may enter this class.
- 7. Jack Benny Barrels: anyone over the age of 19 wanting to complete in barrels
- 8. Pee Wee Barrels: Kids the age of 2-7 or 8 and not in 4-H can enter this class. They may be led or on their own
- 9. Egg and Spoon: is based on how you can balance an egg in a spoon while completing the task the judge asks for. If egg drops you are to immediately report to the center of the arena. You have 3 strides to pick up or drop down to the gair asked.
- 10. Station 490: Ride (lead for minis) horse across timer, save "Baby/animal" and ride/lead back across timer. DQ if animal/baby is dropped during rescue.
- 11. Bribery: Ride (lead for minis) horse across timer, go to and around barrel, grab carrot and have horse follow you back across timer without touching them.
- 12. Pony Express: consist of two riders. One will start on the left side of the arena between two cones and run up and around the barrel and end on the right side between two cones. Second rider may start their run after the first runner goes through the right side set of cones. Second rider will run up and around the barrel and finish between cones on the left side of the arena. Times will be added together. No going around the barrel, not going between cones or complete lack of control (Judge's discretion) will result in a DQ.
- 13. Agility: The pattern is in the pattern book. A 5 second penalty will be added if barrel, pole or cone is knocked over and a DQ if pattern is not run correctly.
